Regulations on Representation of Teaching Students at the Georg August University in Göttingen (Teaching Students Representations Regulations – LSVO –)

§ 1 Regulatory area

(1) ¹These regulations govern the establishment of a representation of teaching students at the Georg-August-Universität Göttingen. ²It is a supplementary regulation to the organisational statutes of the student body (OrgS) in the currently valid version.

(2) ¹Teaching students are all students who are enrolled in a teaching study programme. ²Teaching degree programmes within the meaning of these regulations are the two-subject Bachelor's degree programme with the teaching profile, the Master of Education degree programme with the exception of the subject Business Education, the degree programme "Lehramt an Gymnasien" and students in the third teaching subject (Lehramt an Gymnasien).

§ 2 Teaching Students Representation (LSV)

(1) The Teaching Students Representation (LSV) is both the coordinating body of the Subject Representations in matters of teaching education at the University of Göttingen and the representation of the teaching students named in § 1 subsection 2 sentence 2.

(2) 1At the beginning of each legislative period, the Subject Parliament shall elect the following members for the duration of the legislative period with a majority of the voting members

- of the Faculty of Humanities

two voting members;

and the Subject Parliaments

- of the Faculty of Biology and Psychology
- of the Faculty of Chemistry,
- of the Faculty of Earth Sciences and Geography,
- of the Faculty of Mathematics and Computer Science,
- of the Faculty of Physics,
- of the Faculty of Social Sciences and
- of the Faculty of Theology

one voting member each of the LSV; § 11 OrgS shall apply accordingly. 2Students who are members of the sending subject representation due to their studies in one of the degree programmes according to § 1 subsection 2 sentence 2 shall be entitled to vote passively.

(3) 1Each subject representation must elect at least one representative. 2For the election, subsection 2 shall apply accordingly.

(4) Advisory members of the LSV are:

a) the student members of the Board of the Central Academic Institution for Teacher Education (ZEWIL) as well as of the Study Commission for Teacher Education (Studienkommission Lehrerbildung),

b) the members of the AStA,

c) the student representatives of the sending departments who are not members,

d) the student representatives of the economics student body.

§ 3 Tasks of the LSV

(1) The tasks of the LSV shall be, in particular

a) the coordination of the teaching-related work of the subject representations and subject groups of the faculties involved in the teaching degree programmes,

b) the support of the work of the student members of the Study Commission Teacher Education as well as the ZEWIL Board,

c) the promotion of the level of information and the formation of opinion among students with regard to teacher training,

d) the election of the LSV spokesperson, deputy LSV spokesperson and LSV financial officer.

(2) ¹The tasks of the LSV shall also include the adoption of the LSV budget; the Student Parliament shall allocate budgetary funds to the LSV for its own use within the framework of the budget of the student body for the fulfilment of its tasks. ²Further details are regulated by the Financial Statutes.

§ 4 The organs of the LSV

(1) ¹Organs of the LSV are:

- a) LSV-Spokesperson,
- b) LSV-Financial Officer.

²The spokesperson of the LSV shall be the executive body of the LSV and shall be responsible for the day-today business of the LSV. ³They represent the LSV; convenes the meetings of the LSV and chair them. ⁴If they are prevented from doing so, the tasks shall be carried out by the deputy LSV spokesperson.

⁵The LSV Finance Officer is responsible in particular for the tasks according to § 5 FinO as well as for expenditures within the framework of the LSV budget according to § 3 subsection 2, which are necessary for the fulfilment of the tasks of the LSV. ⁶If the LSV spokesperson is prevented from fulfilling their duties, they shall do so.

(2) ¹The LSV spokesperson, the deputy LSV spokesperson and the LSV financial officer shall be elected by the LSV from among the teaching students within the meaning of § 1 subsection 2. ²The person who receives the majority of the valid votes cast shall be elected. ³§ 11 OrgS shall apply accordingly. ⁴The terms of office shall be one year and shall begin on 1 April; the LSV organs shall hold office on a provisional basis until new elections are held; re-election shall be possible.

(3) If an office holder steps down prematurely in accordance with subsection 2 sentence 1, a meeting of the LSV shall be convened without delay for the purpose of a new election until the end of the term of office

§ 5 Rules of Procedure of the LSV

(1) 1The Speaker of the LSV shall invite the voting and consultative members at least seven days before the meeting. 2The invitation must at least be in text form. 3The LSV spokesperson shall announce the meeting to the university public on the day of the invitation at the latest.

(2) The LSV shall meet at least once a semester and as soon as possible, at the latest within 14 days,

a) after receiving all protocols of the constituent meetings of the Subject Parliaments of the sending Subject Representations in accordance with § 2 subsection 2 of the corresponding legislature,

b) at the request of at least two voting members of the LSV,

c) at the request of the AStA,

d) at the request of a student member of the Teacher Education Study Commission or the ZEWIL Executive Board, or

e) at the request of the Subject Speakers of the sending Subject Representations.

and shall be convened by the LSV spokesperson in accordance with subsection 1.

(3) 1The LSV shall meet in public session. 2It may exclude the university public by a two-thirds majority or restrict it to the student body public if the interests of the representation of student teachers so require.

(4) 1For resolutions of the LSV, § 6 subsections 1 to 5 OrgS shall apply accordingly. 2Resolutions shall be forwarded by the LSV spokesperson to the AStA and published in an appropriate form.

(5) 1Resolutions shall be passed at meetings or by circular (in writing, by fax, by telephone or electronically). 2The LSV spokesperson shall inform the voting and advisory members of the LSV of the time, content and procedure of the circulation procedure before the beginning of the circulation period; the voting members of the LSV shall inform the deputy if they are prevented from attending and inform the LSV spokesperson of this. 3The circulation period shall be at least one week. 4For elections and in personnel matters, a resolution by circulation procedure is excluded. 5The adoption of a resolution by circulation procedure shall be recorded in a note by the LSV spokesperson.

§ 6 Entry into Force

1The above regulations shall enter into force on the day following their publication in the Official Notices I of the Georg-August University of Göttingen. 2The Regulations on the Representation of Student Teachers at the Georg-August University of Göttingen (LSVO - Regulations on the Representation of Student Teachers) in the version published on 19.02.2015 (Official Notices No. 8/2015 p. 61) shall expire at the same time.
